April - 13 reported violent gang related incidents - 32% decrease from March which had 19 incidents.

April 3 - Foothill division - gang motivated homicide Danali way and Lanai ave - still under investigation

April - 1 Gang related burglary and 11 gang related aggravated assaults (5 were with a firearm)

May -17 reported violent gang related incidents - 31% increase from April which had 13 incidents

May 6 - western division - gang motivated homicide Saltic and Baltic way. Not initially classified as gang. SJPD has made 2 arrest and has reclassified it as gang related.

May 2 - gang related robberies and 14 aggravated assaults (8 were with a firearm)

May - no gang related incidents in the Central Division

Mayor Reed's Update

June was a busy month in San Jose

Council approved the budget and approved the Medical Marijuana Ordinance

In the budget, the councils approved an additional \$1,000,000 for MGPTF to help address girls in gangs and some after school issues

Council also approved focusing efforts with East Side Alliance on closing our achievement gaps and focusing on our schools.

Council approved a strong and effective regulatory system for medicinal marijuana which is required under the federal guidelines and allows for compassionate uses permitted under state law. We wanted to make sure we are protecting our neighborhoods and schools and keeping it away from our kids. It prohibits the following:

Sales to anyone under 21

Anyone under 21 to be on premises

No on site consumption

Must be 1000 ft from school

Must be 1000 ft from playground

Sub Committee Updates -

Pastor Danny Sanchez - Community

One of the strategic goals of the MGPTF subcommittees is to strengthen and expand the ongoing faith based partnerships.

Night walks have been going great. The first night walk was in the Alum Rock area near St. John Vinnie the original route was re routed to increase visibility. The communities have responded well to night walks. Have had 15 - 30 participants

Beautifully day had 5,000 volunteers working to clean up Andrew hill HS and Independence HS.

Shared facilities MOU

Have 4 faith based organizations committed to share their facilities via MOU's allowing the task force to increase the facility inventory specifically in gang hotspots.

Another subcommittees goals is to strengthen resident awareness, engagement efforts and solutions aimed at reducing gang violence. Interagency Collaborative Report - Mario Maciel

Topic 1 - Funding for the PBIS (positive behavioral intervention system) is allowing us to do a cluster model on the east side starting in elementary then middles and then high school providing consistency.

Topic 2 - alternative site for one of the Santa Clara County alternative schools. Unfortunately the San Jose Unified School Board did not approve our lease agreement. We are now again looking for an alternative site . We are looking for a facility that could house 6 classrooms.

Topic 3 - Thank you to County Supervisor Chavez for her support with the Trauma to Triumph program. The county budget included \$500,000 to fund more MSW and interventionist to continue and expand the hospital intervention based program.

Technical Team Report - Mariah

The tech team is working on creating an internal work group to address the removal of gang related shrines and memorials

The representatives will be from code enforcement, PRNS, anti graffiti and litter, SJP, and the faith initiative to help address this issue.

Would like to thank the policy team, community engagement committee and city councils for their support with the Marijuana dispensaries and the negative impacts on the schools.

School City Collaborative Report - John Porter

Schools are winding down for the summer but there are more resources to put into after school and summer programs. Happy to report there will be more students in summer school than the last 5 years. Will have all of the middle school and 2 of the high schools running full summer programs. We have summer programs running through all of our elementary schools.

The East Side Alliance is continuing strong. 8 superintendents are focus on the brand new standards from before.

Construction is about to start in Santee for the 38000 sf building for year around family services.

7 trees community reconfigured 2 schools. 1 school will be K-3rd and a block away will be 4-8 grade

Team kids Report - SJP

6 week Gang prevention and youth safety program pilot at Santee elementary in 2 5th grade and 2 6th grade classes to steer you away from the gang life.

Based on the 10 week choices and challenges curriculum.

Focus on 5 core lessons - zero tolerance, choices and consequences, peer pressure, bullying and harassment, and gangs.

Conclude with a class project.
