Abe Andrade, Redevelopment Agency, presented the Redevelopment Agency Monthly Financial Reports. Staff will research and report back to Member Oliverio the MACSA property purchase price. Upon motion of Vice Chair Constant, seconded by Member Oliverio, the Committee accepted the report.

**7. An Audit of the San Jose Municipal Water System Consolidated Water Utility Fund Transfers (Auditor)**

Gerald Silva, City Auditor, presented the Audit of the San Jose Municipal Water System Consolidated Water Utility Fund Transfers. Vice Chair Constant asked how a cap on the dollar amount is adjusted to meet current conditions. Gerald Silva, City Auditor, responded that the policy could be amended or established to allow for adjustments if certain conditions are met. Member Oliverio asked staff to return to Council with a specific recommendation on the adoption of a policy regarding the use and replenishment of the System Rehabilitation/Replacement Reserve Fund and the Rate Stabilization Reserve Fund. John Stufflebean, Director, Environmental Services, said staff is currently working on a policy with the City Attorney's Office and will return to Council with a recommendation. Member Oliverio said water should rise in cost to cover its scarcity. Mansour Nasser added that the San Francisco Water District's final figures will be ready early June and presented to the City Council on June 19 with a recommendation on the final water rate increase. Upon motion of Member Williams, seconded by Vice Chair Constant, the Committee accepted the report.


