



**REGULAR MEETING OF THE SAN JOSÉ
PUBLIC SAFETY, FINANCE AND STRATEGIC SUPPORT COMMITTEE**

City Manager Debra Figone presented the public intoxication advisory group effort and composition report.

Action: The Committee accepted the Staff report, with Staff directed to include two Asian groups in the initial recommended membership of the task force: Asian Americans for Community Involvement (AACI) and one of AACI's partnership organizations.

Action: The Committee accepted the Staff report, with Staff directed to forward the list of bad-debt write-offs, comprised of 92 accounts in the amount of \$1,848,382.09, to the January 13, 2009 City Council Agenda for final approval of the Council.

(h) External Auditor's Reports: Single Audit Report for the Year Ended June 30, 2008 and Reports to the Public Safety, Finance and Strategic Support Committee, Fiscal Year Ended June 30, 2008.

Director of Finance Scott Johnson introduced Cynthia Pon, Macias, Gini & O'Connell, LLP, who briefly described the process. Director Johnson highlighted the main points of the External Auditor reports.


Action: The Committee accepted the Staff reports, with Staff requested to explore less expensive options for account managing, such as Cloud computing solutions for reporting capabilities.
