PARKS FAQ'S

SAN JOSE FAMILY CAMP

Located in the heart of the Sierras just off Highway 120 and the West gate of Yosemite National Park, San Jose Family Camp is a 40-acre self contained campground which provides lodging, meals and recreational activities for the entire family for a nominal fee. Family Camp is currently closed for the 2011 Winter season; but may open again next year from approximately May through mid-October 2012. Summer Employment opportunities are always available at Camp. WHAT ARE THE PARK HOURS?

Neighborhood parks are open from sunrise to one hour after sunset. Regional parks are open from 8:00am until a half hour after sunset, unless posted otherwise.

HOW DO I FIND THE ADDRESS OF A PARK?

Parks normally do not have addresses. They are located by cross streets, or a street and landmark. If a community center is located on a park, the park may be associated with that address. For a listing of park cross streets, visit our Park Listing page at www.sjpark.org.

IS ALCOHOL ALLOWED?

No alcohol is allowed in neighborhood parks, according to San José Municipal Code. Some Regional parks allow alcohol in limited areas.

CAN I RESERVE A SPORTS FIELD OR TENNIS COURT?

Yes, sports facilities are reservable for a fee. Call 408-794-6527.

ARE WATER SLIDES OR DUNK TANKS ALLOWED IN PARKS?

No, the excessive water and activity damages the turf. However, there are several parks that have water features to enjoy.

CAN I BRING MY OWN BBQ IN TO A PARK?

Yes, home barbecues are allowed in most neighborhood parks in the designated cooking areas. Please dispose of briquettes carefully and in designated hot coals containers.

DOG PARKS



San Jose has several parks for owners and their dogs to enjoy. Dog parks include:

RULES INCLUDE

- Dog must be accompanied at all times
- No more than 2 dogs per person are allowed at one time
- Children are not allowed in the dog park, unless accompanied by a guardian
- Owners are responsible for picking up after their dog
- All dogs must wear proof of license and have proper vaccinations
- Dogs in heat are not allowed at the park
- Dogs with bad behavior will be required to leave the park

COMMERCIAL PHOTOGRAPHY:

Photo permits are also required for any commercial photography in all City of San José Parks. You may obtain a photo permit six months in advance.
