Meeting Goal: Discuss preliminary project design and provide comments to staff and applicants.

Proposed Projects for Review:

1. **H20-026:** Site Development Permit for the Eterna Tower Project to allow the demolition of two existing buildings (totaling 14,623 square feet), the construction of a new multi-family residential building (26 stories) with a total of 200 residential units, including 25% restricted affordable units for low-income residents (36 units), and no proposed parking on an existing 7,762-gross square foot site at 17-21 East Santa Clara Street) and 29-31 East Santa Clara Street.
 - a. Provide initial input and feedback on the design of the proposed new infill building involving a property listed in the Historic Resources Inventory (21 East Santa Clara Street) with regard to Section 4.2.4 (Historic Adjacency) of the San Jose Downtown Design Guidelines and Standards (2019).
