Disability Affairs Update

- We heard from the community in 2022 thank you!
- Council supported City Manager's Organizational Disability Assessment, and appropriated funding for a workplan to improve accessibility in City's programs and services.
- New Disability Affairs Officer continue the assessment, gap analysis and propose recommendations in the next 18 months.



Phase 1 Workplan Objectives

- Catalyze cultural change by building institutional awareness
- 2. Support Disability Affairs organizationally
- 3. Improve accessibility in five areas across departments:
 - I. Communications and information access
 - II. Community sensitivity
 - III. Physical access
 - IV. Employment access
 - V. Shared data collection
- Phase 2 objectives will be informed by outcomes achieved in Phase 1

- Purpose: Establish framework to advance systemic change that normalizes inclusion and accessibility for people with disabilities
- Provides context & formalizes City's commitment
- Modeled after County's pledge, adapted by Michele Mashburn
