INFORMATION

Following are the key activities to be highlighted this week:

Update on State Borrowing Local Property Taxes - Proposition 1A Securitization Program—Due to the State's budget actions, Proposition 1A was suspended resulting in the diversion of \$1.9 billion in local government property tax revenues in fiscal year 2009-10. In addition to suspending Proposition 1A, the 2009 State budget actions also authorized the securitization of Prop 1A property tax receivables. California Statewide Communities Development Authority's ("California Communities") has been authorized to implement the securitization program to enable local government agencies to sell their respective receivable to California Communities. Under this program, in exchange for the participating local agencies Prop 1A receivables, California Communities will simultaneously issue bonds and provide the participating agencies with the cash proceeds in two installments.

On October 20, 2009, Council authorized the City's participation in the California Communities Proposition 1A Securitization Program to offset the City's reduced property tax allocation in 2009-2010 due to the State Proposition 1A borrowing. The Proposition 1A Bonds were successfully sold by California Communities on November 10, 2009 at a yield of 4.00%, and closed on November 19th. The City's Proposition 1A receivable amount is \$20,467,289 which will be distributed to the City in two equal installments; January 15 and May 3, 2010 to coincide with the City's normal property tax distribution schedule administered by the Santa Clara County Controller's Office.

The City will be made whole with receipt of the Proposition 1A bond proceeds from California Communities on January 15 and May 3, 2010. The City has no obligation or credit exposure on the Proposition 1A bonds, there are no restrictions on the use of the bond proceeds, and all bond issuance costs are paid by the State. Community Based Organizations (CBO) Contract Training—On November 13, as a key component of the City's Non-Profit Strategic Engagement Platform, the City held a training with over 140 CBO participants. The focus of the training was to provide grantees with the required information and underlying rationale behind the City's contract preparation, monitoring requirements and process. In addition, information was provided regarding key initiatives that the City will be introducing during the course of the fiscal year, most notably the financial scan of all grantees receiving more than \$200,000 of City funding and the web-based Grants Management System. Grantees were also informed of the City's nonprofit organizational assessment tool and encouraged

MGPTF Community Crisis Response Protocol Gives Rise to Community Forum—On November 10, nearly 300 residents gathered at Lee Mathson Middle School to voice concerns and give input on possible solutions to the recent acts of gang violence in the area. The group determined that the immediate next step was offer late night gyms sessions at Alum Rock Youth Center and Mayfair Community Center on Fridays and Saturdays from 7:00 p.m.-11:00 p.m. for three consecutive weekends. These gym sessions will give area youth a safe recreation environment and afford SJPD and community-based partners (CYO & MACSA) an opportunity to reach out to the students. SJPD also provided residents with an update on the investigation of crimes at the meeting. The forum was hosted by Council District 5 and was a direct response of the Mayor's Gang Prevention Task Force's Community Crisis Response Protocol. The protocol team immediately mobilizes in response to serious crimes involving juveniles and possible gang activity in the city. Their objectives are to provide assistance to students who may have witnessed a crime and to engage the community in determining methods to combat gang activity. Homelessness Prevention and Rapid Re-housing Program (HPRP)—On November 2, the agencies administering the City of San José's stimulus funded Homelessness Prevention and Rapid Rehousing Program (HPRP) began offering services to qualified residents. San José households who are homeless or at-risk of homelessness may be eligible to receive financial assistance for rent, rental deposits, utility payments, and moving costs along with case management services at the following locations —

Airport Passenger Activity Down 8% in October—Passenger traffic at SJC dropped 8.0% in October 2009 compared to October 2008. The rate of decline has slowed in the past two months, which reflects the steep reductions in flights and capacity already made by airlines more than a year ago. Over the past two years SJC has lost more than 25% of its airline capacity, both in the number of flights and seats available at the Airport. The Airport's forecast for the current fiscal year estimates that traffic will be down approximately 7.5% overall compared to FY 2008-09. Airport staff continues its efforts to encourage airlines to restore flights to SJC and work with Silicon Valley business and community leaders to support air service development in anticipation of both the completion of the modernization program next year and economic recovery. Horizon Air to add direct flights from San José to Spokane and Sacramento—Horizon Air announced that it will launch twice-daily service from San José to Spokane starting March 26, 2010. One of the daily flights from San José will stop in Sacramento and continue on to Spokane, while a

second flight will operate nonstop to Spokane. All flights will be operated with 76-seat Bombardier Q400s, a high-speed, twin-engine turboprop that is one of the most technologically advanced regional aircraft in the world. The Q400 is also among the most environmentally-friendly aircraft today, burning 30% to 40 % less fuel and producing an equally lower amount of emissions and less noise than comparable jets. Last week Horizon's affiliate carrier, Alaska Airlines, also announced it will begin direct service between San José, Maui and Kona, Hawaii, starting in March 2010. In addition Horizon will provide seasonal service to Mammoth Lakes beginning December 17. For more information, contact Bill Sherry, Airport Director, at 501-7600.

Purchase of Roundtable Drive Property—On November 12, the Housing Department closed escrow on the first property purchased under the Neighborhood Stabilization Program (NSP). The NSP, originated from the Housing and Economic Recovery Act of 2008, was established to stabilize communities suffering from foreclosures. Through the purchase and redevelopment of foreclosed and abandoned homes, this Program will assist municipalities in preventing the neighborhoods hardest hit from the foreclosure crisis from further decline. The four-unit apartment building, located on Roundtable Drive in the Edenvale Great Oaks SNI area, will begin rehabilitation in January 2010 with a completion date of June 2010. CDBG Proposed Changes—On November 12, Housing Department staff presented the 2010-2011 CDBG process and funding priorities at the Housing and Community Development Advisory Commission (HCDC) meeting. Representatives from approximately 20 agencies were present and commented on the outreach efforts and new funding structure. The agencies requested (1) a postponement on the Notice of Funding Availability to allow more time to comment on the proposed changes, and (2) an extension to the application due date from December 2009 to January 2010. CDBG staff held a meeting on November 18 to clarify the proposed changes and provide an opportunity for the agencies to provide final input. Prior to the HCDC meeting, staff hosted two meetings to discuss the proposed changes which included a CBO Roundtable on October 2, 2009, and a meeting of the Silicon Valley Council of Nonprofits on October 13, 2009.
