

INFORMATION

The Department of Transportation (DOT) is responsible for maintaining 2,365 miles of street pavement throughout the City. Each year, an annual pavement maintenance plan is developed and implemented based on available resources, street and network conditions, and the City and department priorities. This information memorandum has been prepared to provide the City Council with a description of the current pavement conditions and funding needs and an overview of the major pavement maintenance projects planned for 2010.

Pavement Conditions

The City utilizes Pavement Management System (PMS) software developed by the Metropolitan Transportation Commission to provide an assessment of street conditions and to perform much of the analysis needed to develop the annual pavement plan. The PMS uses standardized condition assessment criteria that rate each street on a Pavement Condition Index (PCI) scale from 0 to 100, with 0 being a completely dilapidated or dirt road and 100 being a newly paved street. The same PMS software is currently used by over 100 Bay Area jurisdictions.

Overall, the City's street network has an average PCI rating of 64, which is considered an "at risk" rating. An at risk rating means that the network is nearing a point where it will rapidly deteriorate and the future treatments required to bring it into an overall good state of repair will be significantly more costly – at least six times more costly – than the maintenance treatments required now. Concurrently, 82% of the City's streets are rated in acceptable or better condition (50-100 PCI), which conversely means that approximately 425 miles of streets are in poor condition (0-50 PCI). The table below provides a breakdown of pavement conditions by Council District:

The average rating of 64 PCI for all streets in the City is the lowest among all jurisdictions in Santa Clara County. A listing of pavement conditions throughout the County is provided in Attachment A.

Pavement Maintenance Funding Needs

The City's pavement maintenance program has suffered significant funding reductions in recent years, which have led to a decline in street conditions and a growing deferred maintenance backlog that is currently estimated at \$249 million. To maintain the City's streets in good condition, it is estimated that approximately \$39 million is needed annually. Unfortunately, projected funding levels over the next five years will result in an annual shortfall between \$20 million and \$30 million and a growing backlog of deferred maintenance needs. As a result, it is projected that in about five years, the average PCI rating will drop to 56 and only 65% of the City's streets will be in acceptable or better condition. This means that approximately 830 miles of streets will be in poor condition throughout the City and likely require very costly resurfacing treatments.

Development of Maintenance Projects and Street Locations

Each year, pavement maintenance projects are developed and implemented to preserve the condition of the entire street pavement network, improve the condition of specific streets, and minimize future maintenance costs to the greatest extent possible. Also considered is the need to address critical infrastructure related situations, support inter-agency projects, improve sidewalk accessibility, and test new products and treatment applications. Due to the sheer size of the street network and the limited funding available, a prioritization system is used to select the streets that receive maintenance treatments each year based on the following criteria:

1. Grant funding requirements
2. Street conditions appropriate for specified treatment
3. Streets due, or past due, for maintenance based on prescribed maintenance cycles (eight year cycle for arterial streets and ten year cycle for residential streets)
4. Streets with numerous maintenance requests or unique needs
5. Streets with shared maintenance responsibilities with other jurisdictions
6. Streets not affected by current or future street related projects
7. Continuity of street segments (create multiple, continuous segments)
8. Appropriate distribution of street maintenance throughout the City

Scheduled Maintenance Projects for 2010

Due to a delay in the release of funds from State Propositions 1B and 42 in FY 2008-09, and the unexpected funding received from the American Recovery and Reinvestment Act (Federal Recovery Act), the 2010 program will provide a greater level of treatment on distressed arterial roadways than afforded in previous years while allowing a similar, but not ideal, level of preventive maintenance treatments on streets throughout the City. Attachment B contains the list of street segments established for each project. It is noted that the lists could be slightly altered as unforeseen conditions arise or new information regarding other street related projects become available.

Federal Recovery Act Resurfacing Tier 1 and Tier 2 Projects

The City received approximately \$15 million in funding from the Federal Recovery Act. This funding is being used to perform two resurfacing projects: a Tier 1 project that will resurface 15 miles and a Tier 2 project that will resurface 10.5 miles of arterial streets. The Tier 1 project was awarded in August 2009 and is currently under construction with expected completion before the end of the fiscal year. The Tier 2 project is scheduled for award by the City Council on April 13, 2009. It is anticipated that this project will start in July 2010 with completion before the end of the calendar year.

Residential Street Sealing 2010

Approximately 77 miles of residential streets are scheduled for a double surface sealing application in the summer of 2010. In-house maintenance staff will apply the first layer of oil and aggregate seal beginning in July of 2010 and the final sealing treatment will be applied as part of an estimated \$3.2 million slurry seal contract shortly thereafter. The slurry contract is expected to be brought to the City Council for award on April 20, 2010.

Arterial and Collector Street Sealing 2010

Approximately 68 miles of arterial and collector streets will receive a surface seal treatment. This project is designed to address streets in acceptable or better condition and it is one of the most cost-effective ways to preserve and extend the service life of the roadways. The slurry

contract is expected to be brought to the City Council for award on April 20, 2010 with construction to begin in June 2010.

Residential Street Resurfacing 2010

Approximately 14.5 miles of residential streets are scheduled to be resurfaced in the summer of 2010. 8.5 miles of these streets require extensive preparation prior to resurfacing, which will be performed contractually. Award of the project by the City Council is scheduled for May 11, 2010 with construction scheduled to begin in June 2010. The remaining six miles of residential streets require a minimal amount of road preparation will be completed by in-house pavement crews this summer.

Summary

Maintaining the street pavement network is a tremendous challenge due to the sheer size of the network, limited funding and the escalating costs due to deferred maintenance. With significant funding shortages for pavement maintenance projected in the coming years, the City will not be able to deliver the amount of maintenance needed each year to sustain the street network in good condition. Unless new funding sources are realized, the condition of the City's streets will continue to deteriorate and the amount of deferred maintenance will continue to grow.

Staff will continue to work with the City Council on exploring and pursuing new funding sources to improve and preserve the City's street pavement. In addition, staff will continue to research, test and utilize new technologies and materials, including more environmentally friendly options, in an effort to reduce the existing backlog, maximize the usage of our available funding, and maintain the City's pavement infrastructure in the most cost effective and innovative way possible.
