INFORMATION

The purpose of this informational memorandum is to provide the Council with a list of marijuana businesses currently operating within the City of San José, their status regarding filing of the required monthly Marijuana Business Tax ("MBT") returns and payment of the required MBT.

Effective March 1, 2011, any person engaged in marijuana business in the City shall pay a MBT of 7% of gross receipts to the City. Taxes on gross receipts for each month are due on or before the last day of each following month. If the due date falls on a Saturday, Sunday, or holiday, the due date will be the next regular business day on which City Hall is open to the public. The tax rate has been set at 7% of gross receipts. Please refer to San José Municipal Code ("SJMC") Section 4.66.090 for the full definition of "gross receipts." As defined in SJMC Section 4.66.140, "sale" means and includes any sale, exchange, or barter.

The attached spreadsheets divide marijuana businesses into two categories: Active and Closed businesses. Each spreadsheet identifies if the businesses filed MBT tax returns in the categories listed in the table below.
