The League of California Cities (LOCC) will hold its annual conference in Los Angeles at the Los Angeles Convention Center, September 3 - 5, 2014. The conference begins on Wednesday, September 3, with policy committee meetings and the Opening General Session followed by Los Angeles' Host City Reception at the Grand Opening Expo Hall.

The City of San José has a long history of attending the League's conferences and participating on the organization's Board of Directors and policy committees.
