INFORMATION

BACKGROUND

On September 22, 2015, the City Council approved the Pilot Transitional Housing Community for the Homeless. As part of the discussion on this item, the City Council requested that the Housing Department provide a list of all existing affordable rental housing developments in the City by Council District.

ANALYSIS

Since 1998, the Housing Department has funded or facilitated the development of 16,304 affordable apartments. Another 1,742 apartments were funded by federal funds without any additional City subsidy. This equates to a total of 18,046 deed-restricted, affordable apartments. Deed-restricted rental housing must comply with certain rent and income limitations for a set period time, usually 30-55 years. A complete list of affordable apartments by City Council District is provided as an attachment.

The Housing Department's Asset Management Program manages the monitoring and compliance of the affordable rental housing portfolio. The team is responsible for reviewing the rents for all the City-funded apartments to ensure that rents are being charged in conformance with the affordability restriction that was recorded on each property as consideration for funding by the City. The Housing Department invests in the production of affordable housing to maintain, preserve and ensure the financial viability of the properties. The Housing Department's Asset Management staff also oversee payment and collection on loan repayments from the affordable rental housing loan portfolio.
