#### **INFORMATION**

This memo provides a progress report on the priorities set by Council at the June 23, 2015 Council Priority Setting Session.

There are 21 items on the Priority List (Attachment A), which is presented in priority order as ranked by Council. In most cases, work crosses multiple departments and requires legal work from the City Attorney's Office.

The list includes an update on actions taken since the Council Priority Setting Session and next steps.

#### EARLY CONSIDERATION PROCESS – GREEN-YELLOW-RED

The new Early Consideration Process has been adopted and used at Rules and Open Government Committee meetings since the last Council Priority Setting Session.

The following referrals were greenlighted by the Rules and Open Government Committee and added to department workplans or went directly to Committees or Council for action:

- End of Watch Police Memorial (August 5, 2015) Establish a planning group, staffed by the Office of Cultural Affairs, for the purpose of planning for a San José End of Watch Police Memorial.
- **Fix Our Roads Resolution** (August 19, 2015) Resolution in support of the Fix Our Roads Coalition's goals for the California State Transportation Special Session.
- Changes to Title 6 and Title 25/Transportation Network Companies and Taxis (August 19, 2015) Evaluate and recommend any changes to Title 6 and Title 25 of the San José Municipal Code as they pertain to Taxicab and Limousine Service Regulations in an effort to provide consistency in respect to the regulation of the Transportation Network Companies.

- **Minimum Wage Study** (September 2, 2015) Hire a professional, non-biased consultant for the Minimum Wage Study and engage key stakeholders in the process of the study.
- Legal Work on Elections (September 23, 2015) Assessment of the feasibility of the City Attorney providing all written guidance for candidates for office regarding legal compliance with relevant municipal, FPPC, state, or other regulations relating to elections; to all questions from candidates and councilmembers relating to election rules, including compliance, filing deadlines, reporting of contributions; and Any other inquiries relating to the Code of Ethics, including but not limited to rules regulating gifts, honoraria, and lobbying.
- **Lincoln Avenue Road Diet** (September 23, 2015) A comprehensive traffic study which includes traffic analysis and sales tax impacts.
- Crime Free Multi-Housing (October 7, 2015) Coordination of community stakeholder with analysis from the Police and Housing Departments as well as legal analysis of from the City Attorney.
- **Resolution in Support of H.R. 2140** (October 7, 2015) Resolution against torture and in support of the Vietnam Human Rights Act of 2015 (H.R. 2140)

The following items have been <u>yellow lighted</u> and referred to the next Council Priority Setting Session:

- Expanding Information Technology Capacity (June 9, 2015 Council) Exploration of recommendations related to the City's Technology Investment Strategy.
- San José Urban Agriculture Incentive Zones Ordinance (October 7, 2015) San José Urban Agriculture Incentive Zones Ordinance.

These items will be returning to Rules for further direction:

- **Gender Pay Equity** (September 9, 2015) *Options for assessing and promoting gender and ethnicity equity in the City's employment decisions.*
- License Plate Readers on Garbage Trucks (August 19, 2015) Exploration of the feasibility, legality, and civil liberties implications of mounting license plate readers on garbage trucks owned by our four recycling providers to provide investigative data directly to the San José Police Department
- **Electronic Billboards** (October 6, 2015 Council) *Options for public and private property that will allow electronic digital off-site advertising signs or billboard installations.*
- **Downtown Sign District Pilot Program** (October 6, 2015 Council) *Establishment of a Sign District in a limited area of the Downtown that provides opportunities for offsite advertising on public and private buildings and generates revenues for public art and cultural programming.*
