SUBJECT: REPORT ON ACTIVITIES UNDERTAKEN BY THE DIRECTOR OF AVIATION UNDER THE DELEGATION OF AUTHORITY ORDINANCE FOR THE PERIOD OF JANUARY 01-MARCH 31, 2016.

EXECUTIVE SUMMARY

The San José Municipal Code authorizes the Director of Aviation to negotiate and execute Operating Agreements, Permits, Licenses and Leases on behalf of the City.

In accordance with the Municipal Code's reporting guidelines, this memorandum details actions taken under the delegation of authority to the Director of Aviation for the third quarter of FY 2015-2016 (January 01-March 31, 2016). During this reporting period, the Director of Aviation approved actions to: (1) execute airline and operating, lease, right of entry, and ground vehicle fuel agreements; and (2) execute ground transportation permits.

This activity is summarized in Attachment A.
