OF AVIATION UNDER THE DELEGATION OF AUTHORITY ORDINANCE FOR THE PERIOD OF APRIL 1 - JUNE 30, 2019

EXECUTIVE SUMMARY

The San José Municipal Code authorizes the Director of Aviation to negotiate and execute Agreements, Permits, Licenses and Leases on behalf of the City. In accordance with the Municipal Code's reporting guidelines, this memorandum details actions taken under the delegation of authority to the Director of Aviation for the fourth quarter of FY 2018-2019 (April 1 - June 30, 2019). During this reporting period, the Director of Aviation approved actions to: (1) Execute Concession Amendments; (2) Execute Ground Transportation Permits; (3) Execute License Agreement; (4) Execute Non-Signatory Airline-Airport Operating Agreements; (5) Execute Right of Entry Agreement and Amendment; and (6) Execute Signatory Airline-Airport Lease and Operating Amendments.

This activity is summarized in Attachment A.
