City Attorney Deputy City Attorney Matthew Tolnay reported that the Board of Fair Campaign and Political Practices' Biennial Review recommendations were discussed by the City Council, and direction was given for the item to be brought back to City Council in August 2023 with additions from the City Attorney's Office. An ordinance with recommended changes to Title 12, discussed by former Councilmember Maya Esparza and the BFCPP, is scheduled to be placed on City Council agendas on June 13, 2023 and June 20, 2023 for approval. Deputy City Attorney Tolnay also noted that he will be tracking AB 83 from Assemblymember Lee, regarding foreign influence in elections. Deputy City Attorney Tolnay answered questions on the status of BFCPP recommendations from Board Members Vasundhara Tadimeti and Tom Pavel.

<u>Discussion</u>: Assistant City Clerk Joy Rodriguez confirmed that no scheduling of a special meeting is necessary.

VIII. New Business

A. Discussion and possible action on RFP for Investigator/Evaluator. (City Clerk)

<u>Discussion</u>: Assistant City Clerk Joy Rodriguez reported that the City has pre-awarded the Investigator/Evaluator contract to Hanson Bridgett LLP. Two applicants responded to the RFP, Hanson Bridgett LLP and JL Group. Hanson Bridgett LLP received a rating of 86.2/100 and JL Group received a rating of 60.8/100. JL Group did not respond to the supplemental request from the City for a best and final offer, and was eliminated from consideration by default. The awarding of the contract is subject to City Council approval and will be placed on the City Council agenda for June 20, 2023. Board Member Baltazar Lopez inquired about the outreach process and Assistant City Clerk Joy Rodriguez responded. Investigator/Evaluator Steven Miller, on behalf of Hanson Bridgett LLP, thanked the Board for their recommendation and clarified the scoring process for the applicants.
