File No. PDC22-088, PD22-020, T22-030 & ER22-195 - Planned Development Zoning (File No. PDC22-088) to rezone the project site from the R-M Multiple Residence Zoning District to a UR(PD) Planned Development Zoning District. Planned Development Permit (File No. PD22-020) to allow the removal of 33 trees (13 ordinance-size, 20 non-ordinance-size) for the construction of up to 14 multifamily residential units including the reconstruction and conversion of an existing single-family house into a duplex and the construction of 12 townhouses configured in four three-story buildings on an approximately 0.63-gross acre site. Vesting Master Tentative Map (File No. T22-030) to subdivide one parcel into two parcels and allow up to 14 residential condominiums on an approximately 0.63-gross acre site. Project Location: 4146 Mitzi Drive. Council District: 1.

File No. C22-125) and File No. H22-041 - Conforming Rezoning (File No. C22-125) and Site Development Permit (File No. H22-041) - Conforming Rezoning from the A(PD) Planned Development Zoning District to the MUC Mixed-Use Commercial Zoning District and a Site Development Permit to allow removal of two walls, a portion of the roof, a side door, and a portico, for the construction of a 1,149-square-foot addition to an approximately 3,476-square-foot proposed dental office, on an approximately 0.43-gross-acre site.
