COVID-19 Vaccination and Testing: Per the City's COVID-19 Mandatory Vaccination Policy, the City requires all new hires to provide proof of vaccination as a condition of employment absent an approved medical or religious exemption. Fully vaccinated means a person has received the following: Two doses of the monovalent Pfizer COVID-19 vaccine; or

- Two doses of the monovalent Moderna COVID-19 vaccine; or
- Two doses of the Novavax COVID-19 vaccine; or
- One dose of the Johnson & Johnson COVID-19 vaccine; or
- One dose of the bivalent Pfizer COVID-19 vaccine; or
- One dose of the bivalent Moderna COVID-19 vaccine.
