## Good afternoon, Alex:

We are currently reviewing case law concerning the enforcement of time limits on the display of election signs. While we conduct this review, the City will not be enforcing the time limit restrictions for election signs contained within Section 23.04.760 of Part 8 of Title 23 of the San Jose Municipal Code.

As a result, the City will treat election signs as temporary signs which your campaign may distribute and display now. Please note that while the signs may be displayed now, they must meet the standards for temporary signs contained in Section 23.04.610 of Part 7 of the Municipal Code.

Yes, I have an additional clarification question because unfortunately, your email left me confused. I was hoping for a more direct answer.

Part 7 covers temporary signs.

Part 8 covers election signs.

Part 8 says, "This part shall govern standards for temporary signs that are election signs." But my reading of your email seemed to indicate that election signs in businesses are actually considered "Temporary Signs" and thus not restricted to "...an election beginning on the first day after the opening of the nomination period for the election."

Can you please confirm that the City's Code allows my campaign to distribute signs for my campaign for businesses that can then elect to put them up as of now?

The City treats election signs placed in windows as "temporary signs" which are permitted by, and subject to, the regulations of Part 7 of Chapter 23.04 of Title 23. Please refer to Section 23.04.610 within Part 7 for the specific temporary sign standards applicable to elections signs in windows, including size limitations and the manner in which such signs may be affixed to windows.




