RECOMMENDATION: Review and take action on the recommendation to approve the design development

proposal by artist Jesse Hernandez for an artwork treatment on the exterior of the

new Fire Station 8.

DATE OF ARTIST SELECTION: September 2022

ARTWORK BUDGET: \$125,000

LOCATION: The new Fire Station 8 that will be built at 601 E Santa Clara Street in Downtown San José.

BACKGROUND:

The passage of the Measure T Public Safety Bond in the November 2018 election supported plans for the City to build a number of new fire stations. A new Fire Station 8 one of those. Located on E. Santa Clara Street at 13th Street it will replace an older, smaller station located further east on Santa Clara Street.

Fire Station 8 was already significantly designed when the project was opened up to the City of San José Public Art Program's (SJPA) for direct involvement. In the collaborative discussions that ensued between Public Works, Fire Station 8 architect and SJPA staff the location for a public art element that was most ideal with high visibility and high impact (that aligns with the Public Art Masterplan) are the walls facing Santa Clara Street that flank the gated entry to the station lot. This location requires artistic approaches that are 2-dimensional or bas-relief work. Given the physical and structural characteristics of this site and its proximity to the sidewalk along this very busy urban corridor, there was agreement that some form of flatscape metal mural artwork would be the best option. As design work for the project must be completed in the coming months, it was therefore necessary to bring a skilled, experienced public artist on board as soon as possible so use of the existing mural artist roster was employed; artist; Jesse Hernandez was selected from the SJPA mural artist roster.

Artist Jesse Hernandez is a highly accomplished mural and visual artist. He's completed a mural project (located on DuPont St.) comprised of four largescale murals for the San José Public Art Program's "Right the Blight" project. He has completed other projects in locations including the Oakland Museum of California and in commercial settings San Francisco, Napa and others. His creative work is featured in a wide range of settings that include work for major local professional sports franchises as well as for the SF Symphony and the US Mint. He describes his style as "Urban Aztec," a combination of street art and Aztec influences, capturing movement and depth fused with sharp lines, and powerful color. He considers creation of public artworks to be the ultimate medium, and he is drawn to transforming surfaces and sites into a new spectacle, creating historic landmarks and interactions. He always seeks to honor the community and value their input when creating a new artwork. His stated goal is to create something that will inspire future generations.

Bringing Jesse Hernandez onto this project also achieves a goal of engaging a local artist in a project of a different scale than they may have previously worked on which will support expansion of their capacity as a public artist.

CONCEPT & DESGIN DEVELOPMENT

Artist Jesse Hernandez's approved artwork design is for a metal "mural" on the two walls flanking the entrance to Fire Station 8's gated exterior rear lot. His design is focused on cultural imagery of Tlaloc, the Aztec folkloric deity associated with water, aligned to the very direct relationship between water and firefighting. Hernandez has integrated contemporary elements related to firefighting into the design, such as imagery suggesting a fire hose and SJFD's badge icon. The Aztec-influenced imagery aligns well to the culture of this area.

The artwork will be displayed on the two walls in mirror image on each side of the entry gate. The artwork will be created in cut metal. SJFD and members of the design team have expressed a preference for the walls behind the cut metal to be painted in fire engine red, the color that is featured on other parts of the building which helps to unify the metal mural design with the architecture. The expressive style of the artwork design provides a counterpoint to the rectilinear design of the facility, making for visual interest and placemaking.

Since the PAC's approval of the concept proposal in June, 2023 Jesse Hernandez has worked closely with his team on design development of the artwork and has refined his original concept design into the design for the fabrication of cut metal artwork elements that will be installed onto the walls. As such, this is the evolution of the artwork's aesthetic design.

PUBLIC OUTREACH

The City's Department of Public Works (DPW) was well underway with the design of Fire Station 8 at the time they convened the public meetings listed below to share proposed designs for the new station and provide for community input on possible approaches to public art. Considerably outreach was done for both meetings.
