Energy and Water Building Performance Ordinance (BPO) Beyond Benchmarking

Water Use Intensity Score by Property Type

The City of San José's Building Performance Ordinance Team has prepared a table of average water use intensity (WUI) scores by property type in San José. Water use intensity is the water consumed per square foot of a building per year, as calculated by EPA's ENERGY STAR® Portfolio Manager®, by dividing all water sources by the building's gross floor area, excluding parking and irrigated area.

The water scores in this table are the average values of water use intensity obtained from benchmarking reports from previous years. This table is to be utilized for the Building Performance Ordinance's <u>Beyond Benchmarking</u> program, to help determine if a building is on the Improvement or Performance Pathway for water. One of the ways a building may qualify for the Performance Pathway is by having a water use intensity score that is 25% below the locally calculated mean for that property type for at least two of the three calendar years preceding its Beyond Benchmarking deadline.
