# Application for CAMPERSHIP 2024

### Applications will be accepted February 12 through August 1, 2024

#### **How Much Fee Support is Offered?**

Family Camp at Yosemite fees may be reduced up to 50% off the standard/core fee for a limited number of participants, as determined by the City of San José - Parks, Recreation and Neighborhood Services Department (PRNS). This discount is only for residents of San Jose and can be applied to Fish Camp 2024 and the Summer Season of 2024. An application covers one tent of up to 6 people for no more than 4 nights.

#### **Campership Guidelines**

PRNS has established guidelines to determine who qualifies for a reduction of fees for specific programs. Applicants and Groups must provide proof of eligibility for all conditions, as noted in verification requirements.

- 1. Must be a San Jose Resident to apply
- Must include copies of all required documents listed below
- 3. Applications will not be processed without the information requested on the form
- 4. Good for the 2024 Summer Camp Season and Fish Camp 2024 only
- 5. Camperships will be awarded on a first come first serve basis, and subject to available funding
- 6. Applications are accepted on a rolling basis between February 12 and August 1.
- 7. Completion of the Campership application does not guarantee approval of a Campership
- 8. Maximum of 6 people per tent
- 9. No more than four (4) nights
- 10. One Campership Application per tent
- 11. All information is confidential

Applications must be submitted at least 14 days prior to the requested camp dates. Please allow 7-10 days after submittal to be notified of award status, which will be by email. Any refunds will be only for amount paid by customer. Refund requested must follow the existing Department of Parks, Recreation and Neighborhood Services refund policies.   - o Once processed our staff will send you an invoice reflecting the final amount due

#### **How to Qualify**

- 1. Be a San Jose resident
- 2. Provide a copy of proof of San Jose residency (car registration, PG&E Bill, Cell Phone Bill)
- 3. Provide one of the following documents: (if providing a copy of the bill, it must be within the last two months, or proof of enrollment in one of the following programs):
  - □ Pacific Gas and Electric (PG&E) *CARE* program
  - California Lifeline (reduced rates for telephone)
  - □ Woman, Infants, & Children (WIC)
  - ☐ Temporary Assistance for Need Families (TANF)
  - ☐ Food Stamps/California Advantage/Calfresh
  - ☐ Supplemental Security Income (SSI)
  - ☐ CA State Unemployment Insurance Benefits
  - Enlisted in the U.S. Military and must be considered an "active" member
