- Enhance Community Safety and Promote Vision Zero Initiatives
- Catalyze Downtown Revitalization and Cultivate Equitable Investment in our Neighborhoods

Federal Budget

- President Biden signed the Consolidated Appropriations Acts on March 9
 and March 23, completing the FY 2024 budget process
- \$3.7 million in federal earmarks coming to San José
 - EIH site, Blossom Hill Affordable Housing, Lake Cunningham, and Vision Zero projects on Monterey Road and Jackson Avenue
- President released the proposed FY 2025 budget of \$7.3 trillion on March 11
- Submitted FY 25 earmarks to Senators Butler and Padilla (House earmark submission deadlines are pending)
- Federal Aviation Administration Reauthorization Bill currently expires May 10

Federal Advocacy

Grant Highlights

- Awarded \$12.9 million Safe Streets and Roads for All grant for DOT and advocated for two Valley Water grant awards totaling \$700K for recycled and purified water
- Pending PRO Housing, RAISE, (3) Climate Pollution Reduction applications

Continued Advocacy

- BART to Silicon Valley Phase II project towards securing full funding grant agreement by end of 2024
- Affordable Connectivity Program to help bridge the digital divide that exists in our low-income communities
- Congress to increase funding for rental assistance programs such as the Housing Choice Voucher Program

State Advocacy

Governor Newsom's 2024-2025 January Proposed Budget

- Released proposed 2024-2025 budget on January 10
 - Included a projected \$37.9 billion deficit
- May Revise budget anticipated in early May
 - IGR will be distributing a letter in late April outlining the City's priorities

Multiple Advocacy Days in Sacramento


- Met with State Delegation to discuss cardrooms on February 5
