The outdoor dining references that are presently within Chapter 20.40, Chapter 20.50, Chapter 20.55, Chapter 20.75, and Chapter 20.100 in Title 20 of the San José Municipal Code will be addressed by regulations listed within revised Part 10.5 of Chapter 20.80, including hours of operation, separation criteria, permit processing and noise parameters. For any proposals that are unable to meet the conditions of the Administrative Permit shall apply for a Special Use Permit. Project Location: Citywide.
