#### SUBJECT: REPORT ON ACTIVITIES UNDERTAKEN BY THE DIRECTOR OF AVIATION UNDER THE DELEGATION OF AUTHORITY ORDINANCE FOR THE PERIOD OF JANUARY 1 – MARCH 31, 2024

### **EXECUTIVE SUMMARY**

The San José Municipal Code authorizes the Director of Aviation to negotiate and execute agreements, permits, licenses, and leases on behalf of the City. In accordance with the San José Municipal Code's reporting guidelines, this memorandum details actions taken under the delegation of authority to the Director of Aviation for the third quarter of Fiscal Year 2023-2024 (January 1 - March 31). During this reporting period, the Director of Aviation approved actions to execute: two lease of airport premises amendments, one right of entry agreement, one lease of airport premises agreement, one option to extend ground lease amendment, one commercial operation permit, and 17 ground transportation permits.
