




NEIGHBORHOOD SERVICES CSA PERFORMANCE MEASURE DASHBOARD




Library Service Quality Rating




Animal Care Center – Live Release Rate




General Code Program Case Backlog




Neighborhood Physical Condition


- Continue providing access to high-quality Library collections, programs, and services

- Continue services at six interim housing sites, three hotel sites, and one supportive parking site, and continue work on previously-directed interim housing portfolio expansion:

 - Rue Ferrari Expansion
 - Cerone and Cherry
- Continue the eviction diversion and settlement program
