BD Cost Estimate Notes (if applicable – provide any notes only if necessary to clarify the cost estimate):

The cost estimate to continue the operation of the Fitness Room located at the Almaden Community Center is based on reduced hours of operation Monday – Saturday for approximately 40 hours a week during fiscal year 2024-2025. This estimate also includes the preventative maintenance checks based on a 935 square foot room and 14 commercial brand name fitness machines. In addition, funding is allocated for the anticipated repairs as needed, but does not include replacement of aged/un-repairable equipment or free weights (dumbbells, mats, etc.). Also, in this estimate are the cleaning and other supplies necessary to continue a safe and professional service. At current levels of participation, the Department expects to generate approximately \$25,000 in revenues to offset the expense.
