Pickleball is one of the fastest growing sports in America. District 10 has a large number of seniors who have discovered that pickleball is a great way to get exercise and to socialize with friends and neighbors. In addition, it has become a sport that all ages enjoy. However, there are no pickleball courts in District 10. Federal grant funding is being pursued. Please provide a cost estimate for building 4-8 courts in Cahalan Park in the area identified by Sara Sellers as well as the breakdown of potential funding sources.

Second to pickleball, our office receives regular request for Cricket fields. This sport has grown in popularity in this area so much that the County is planning a 10,000+ seat stadium at the Fairgrounds. Residents would like to have neighborhood locations they can play with friends and local leagues. Please provide the cost estimate to install one new cricket field in D10.

Costs to deliver one new cricket field (current CD 10 park inventory is not large enough to host a new cricket field as they require 2-4 acres per field. PRNS would need to acquire new land to develop the requested amenities) - \$8,700,000

(Estimates do not reflect full ongoing maintenance*)

Project scope of work to include:

- Land Acquisition \$4,000,000 (assuming \$1.0 million/acre for 4.0 total acres for the acquisition of new park land)
- Master Plan and Design \$700,000
- Construction \$4,000,000 (assuming \$1.0 million/acre for basic infrastructure to support turf and irrigation)
- Ongoing costs* Will be developed later if this project is funded. A minimum of \$42,848 for 0.50 FTE Groundskeeper is known at this time.

NOTE: The fast-track BD process does not permit staff to fully evaluate site conditions. A final project cost may be impacted by unknown site conditions, community input, conflicts with other uses, neighboring conditions and other factors. Conformance with the City's draft Park Design Guidelines may also impact project scope. PRNS will track this request if unfunded, so that the project proposal may be revisited as part of the annual budget process when the Department's Parks Professionals engage the Council Offices in fall and winter of each year with project recommendations based upon known community needs and strategic plan goals.

The Council District 10 C&C Tax Fund lowest Ending Fund Balance in the CIP totals \$260,669 for 2025-2026. Additionally, Park Trust Fund proceeds totaling \$1,000 are available within the nexus of the park. The Cost Estimate designated the General Fund as one of the proposed sources. Based on the minimal other funds available, these projects cannot be implemented without a significant General Fund investment or other external funding source(s). If the project is funded from the alternative source listed, the fund may need to be re-balanced, with existing projects and/or reserves being de-funded. In addition, the delivery of this project will depend on resource limitations in PRNS associated with necessary budget balancing, the existing funded projects, and the number of potential additional projects included in the Council-approved budget.
