- San Jose Clean Energy Assistant Director mentioned that CalCCA will be this April and who would like to attend, Chair Karen Nelson wants to attend.
- Mani Bekele suggested since climate change is an issue to youth, can City Council push school age items to wait until after 4pm that way students can attend the meetings and have an opportunity to participate.
