
Welcome Back CAG Members

San Antonio Street Updates

The San José Department of

Converting Protected Bike Lanes to Buffered Bike Lanes

The protected bike lanes on San Antonio St. between Sunset Ave. and Scharff Ave. were reverted to buffered bike lanes in Summer 2023.


Traffic Calming Between 24th St. and King Rd.

We have received the additional set of traffic calming recommendations for this segment from the DOT traffic engineers. Now, we are in the process of locating funding for implementation.

Traffic Circle Hardening



The DOT is currently in the process of rebidding this project. We expect a contract to be awarded early 2024, with construction expected to begin Summer 2024.



Quick-Strike Movement

After incorporating community feedback into the final designs, **four** of the corridors have been slated to have chicane treatments removed. You can view the preliminary designs and access community meetings on the <u>Quick-Strike webpage</u>.

Santa Clara St. Re-Envisioning Project

McLauglin Complete Streets - Transit Boarding Islands

While installation of the transit boarding islands was scheduled for early Fall 2023, we received higher-than-expected initial bids and are currently in the process of rebidding this project. Contract awards are expected to be issued early 2024, with construction projected to begin Summer 2024.

King Road Updates

Phase two outreach for this project is continuing through early 2024 with our completed King Road Complete Streets Plan scheduled for Spring 2024. The fifth and final workshop will be facilitated as an open house, where the community will be invited to interact with the plan in its completed form.
