Proposed project(s) at 5670 Camden Avenue:

Development Permit (File No. H23-040) allow the demolition of three existing buildings associated with Little League baseball fields, the removal of 45 trees (27 ordinance-size and 28 non-ordinance-size), and the construction of 108 residential condominium units configured in 32 three-story buildings on an approximately 6.67-gross-acre site; and a Tentative Map (File No. T23-027) to subdivide one parcel into two parcels, with one parcel designated for condominium purposes for up to 108 residential units, on an approximately 10.68-gross-acre site. *This project was submitted under the Housing Accountability Act (Builder's Remedy)*.


