#### **INFORMATION**

SUBJECT: Report on Activities Undertaken by the Director of Public Works
Pursuant to Title 27 of the San José Municipal Code for the Period of
January 1, 2024 – June 30, 2024

Title 27 of the San José Municipal Code authorizes the Director of Public Works to negotiate and execute certain Public Works contracts, work orders, change orders, permits, and other related documents needed to implement a Public Works project. In accordance with the San José Municipal Code's reporting guidelines, this memorandum details actions taken under the delegation of authority to the Director of Public Works for the period of January 1, 2024 through June 30, 2024. During this reporting period, the Director of Public Works approved actions to: (1) award construction contracts up to \$1,220,000; (2) execute City-Private Developer contracts; and (3) negotiate and execute change orders.

This activity is summarized in the attachment.
