

Capital Improvement Program Upcoming Procurements

The City of San Jose's Capital Improvement Program (CIP) involves a vast array of projects that include construction, replacement, and renovation of City facilities and infrastructure. The CIP envisions an investment of approximately \$3.7 billion over five years.

The City has consolidated all procurement solicitations on its e-procurement platform, Biddingo (www.biddingo.com/sanjose). All bid documents, questions and answers, addenda, and final results will be available electronically via Biddingo during the procurement process. Interested vendors must register on Biddingo to receive procurement-related notifications and to respond to solicitations.

The City plans to advertise the following solicitations within the next six months. Project descriptions are available from the City's Construction Project Management System (https://cpms-app.sanjoseca.gov/cip/pub/search).
