Dear Dr. Parastou Najaf:

The Federal Emergency Management Agency (FEMA) received documentation from the City of San Jose on July 23, 2024, confirming their adoption of the *Santa Clara County Multijurisdictional Hazard Mitigation Plan 2023*. This jurisdiction is in conformance with the Code of Federal Regulations, Title 44, Part 201, Section 6 (44 C.F.R. 201.6). An updated list of the status of participating jurisdictions is enclosed with this letter.

The adoption of this plan ensures the City of San Jose continued eligibility for funding under FEMA's Hazard Mitigation Assistance programs, including the Hazard Mitigation Grant Program (HMGP), the Building Resilient Infrastructure and Communities program (BRIC), and the Flood Mitigation Assistance (FMA) program. All requests for funding are evaluated individually according to eligibility and other program requirements. Approved hazard mitigation plans may also be eligible for points under the National Flood Insurance Program's Community Rating System (CRS).

The Santa Clara County Multijurisdictional Hazard Mitigation Plan 2023 is valid for five years from the plan's original approval date, **February 8, 2024** for all approved participants. Prior to **February 8, 2029**, all participating jurisdictions must review, revise, and submit their plan to FEMA for approval to maintain eligibility for grant funding.
