The Eastside Alum Rock Urban Village Plan Historic Resources Survey is a part of the preparation of the Eastside Alum Rock Urban Village Plan. The vision for the Urban Village Plan area is to create a more urban, vibrant, and walkable corridor with high-density residential uses and high-intensity commercial/office uses. The Eastside Alum Rock corridor is planned to connect to the future 28th Street/Little Portugal BART station, Alum Rock Light Rail Station, and Alum Rock Transit Center on Capital Avenue.

What is a historic resource survey?

A planning tool for identifying, recording, and evaluating older buildings and places that help to tell the story of an event or important person, community or group, or have distinct architectural character.

What is the project goal?

The goal of the project is to identify older buildings and places in the Eastside Alum Rock Urban Village Plan area and to document their history from the community's perspective. This will inform the preparation of the urban village plan and will help decision-makers consider the protection of properties that are significant to the community and provide a distinct sense of place.
