Good afternoon, Mr. Shoor:

I apologize as it appears previous guidance on this question was not forwarded back to your email account.

Donations made to a bona fide charitable, educational, civic, religious, or similar tax-exempt, nonprofit organization is a permissible use of campaign funds so long as the donation is reasonably related to a political, legislative, or governmental purpose and does not personally benefit the candidate, committee treasure, or any individual with authority to approve the expenditure of campaign funds, or any such person's immediate family member. These donations can be made prior to and after the "surplus fund" designation kicks in.

However, donations to "individuals" that worked on a campaign are not part of this nonprofit donation carve out.

The expenditure of campaign funds which do not confer a substantial personal benefit on the candidate, must be reasonably related to a political, legislative, or governmental purpose. A committee may pay for professional services reasonably required by the committee to assist it in the performance of its administrative functions as those are deemed to be directly related to a political, legislative, or governmental purpose. This includes the professional services of committee members, excluding the candidate, treasurer or other person that has authority to approve expenditures, with a very limited exception.

Additionally, unless directly related to a political, legislative, or governmental purpose, personal gifts may not be paid for with campaign funds.

Once remaining funds are deemed to be "surplus funds" the permitted use of those funds is further restricted and may only be used in accordance with Section 12.06.720 of the SJMC.
