SUBJECT: Report on Activities Undertaken by the Director of Aviation under the

Delegation of Authority Ordinance for the Period of October 1 -

December 31, 2023

The San José Municipal Code authorizes the Director of Aviation to negotiate and execute agreements, permits, licenses and leases on behalf of the City. In accordance with the Municipal Code's reporting guidelines, this memorandum details actions taken under the delegation of authority to the Director of Aviation for the second quarter of Fiscal Year 2023-2024 (October 1 - December 31). During this reporting period, the Director of Aviation approved actions to execute: four airport premise lease amendments, two airline-airport and operating amendments, two food and beverage concession amendments, one ground handling services operation permit, one small concession amendment, one sublease to airport premises amendment and eight ground transportation permits.
