DATE OF ARTIST SELECTION: July 28, 2024

BUDGET: \$20,000 (Budget Document funded through Council District 10, BD 56 for Fiscal Year 2024-2025)

LOCATION: Snell Ave & Snell Way

PROJECT DESCRIPTION

The project is a mural to be painted at Snell Ave & Snell Way. The mural is intended to beautify the soundwall, as well as brighten up a blighted wall. The mural will create a sense of identity for the residents of Blossom Valley and reaffirms the District 10 council office key focus areas by cleaning up the neighborhood.

San José artist Paul J. Gonzalez was recommended for this project by the Blossom Comanche Valley Neighborhood Association. Gonzalez was chosen for his previous experience with public art projects, and his ability to depict a diverse range of subjects in a variety of styles.

CONCEPT AND DESIGN PROPOSAL

The main themes in the mural design reflect community input, and highlights the neighborhood agricultural past, with imagery that includes orchards, cherry blossoms, California poppies, and the surrounding landscape of Blossom Valley, depicted in a graphic design style. The mural will evoke a strong sense of place and identity for all who pass by, welcoming them with the words 'We love Blossom Valley'. It will serve as a vibrant reflection of the community's spirit, making everyone feel connected to the space.
