Proposed project(s) at 511 Cozy Drive:

Development Permit (File No. H23-028) allow the demolition of an existing approximately 35,000 square foot elementary school building, the removal of 63 trees (26 ordinance-size and 37 non-ordinance-size), and the construction of 80 residential units, including 64 detached single-family houses and 16 attached single-family houses on an approximately 9.51-gross-acre site; and a Tentative Map (File No. T23-022) to subdivide one lot into 81 lots (80 residential lots, one common lot), on an approximately 9.51-gross-acre site. *This project was submitted under the Housing Accountability Act (Builder's Remedy)*.
