

Hello Andrea, regarding the Beautify SJ update for the Oct Commission meeting. I have reviewed the update.

Can we please add the following to the update?

- -Can a representative of code enforcement division come to the update and talk about what they do on the enforcement side once PRNS throws the ball over the fence to them on dumping violations?
- -How many enforcement leads have been passed over to code enforcement for each of the last 5 years?
- -How many camera's are in operation currently, meaning set up in the field monitoring hotspots? Are they all up and running at all times?
- -How much does each of these camera's cost?
- -Please update with details on how this camera program is run? Is there someone monitoring the camera's or does someone retrieve video after an illegal dumping is noticed. How are incidents that are identified by the camera's followed up on?
- -How many enforcement actions have been taken as a result of the camera program?
- -How many emails to Report.Dumpers@sanjoseca.gov has the city received in each of the last 6 years?
- -How many of these Report.Dumpers@sanjoseca.gov emails were followed up and investigate by City Staff?
- -How do the individuals that sent the emails get feedback about the resolution of their complaint?
- -How many enforcement actions were taken as a direct result of Report.Dumpers@sanjoseca.gov emails to this hotline in each of the last 6 years?
- -Why has there been no investment in enforcement? Is this for political reasons? Please elaborate in detail what has prevented us from implementing this well known best practice.
- -Show 6 years of trended spending for the total program and each of the sub programs.
- -Show 6 years of trended FTE HC for the total program and each of the sub programs.
- -Has the City ever considered a program to require mattress resellers to provide for free recycling? This relieves the financial burden on the City and puts the costs where they belong with the sellers of mattresses.

Lastly,

FYI, as a heads up and in the spirit of collaboration, I will be making a motion on Wed to pull Beautify SJ from the consent agenda so we can talk in detail about the program during the meeting. Additionally, I will be making a motion to accept the report "but" accompanied by the following statement and two recommendations for City Council.

Beautify SJ - PRC Commission Statement and Recommendations for Council:

The lack of enforcement of dumping and littering laws is shameful, defies common sense and is financially irresponsible. Enforcement is the third tier of successful blight prevention programs which has been completely missing from the SJ program. There is absolutely no deterrence to any dumper or litterer in the City because the city does nothing to hold them accountable. The nominal fines currently collected don't even cover the costs to administer the fines. The costs of trashing our city must be charged to the perpetrators and not to the law abiding residents of San Jose. An aggressive enforcement program will generate significant revenues which will offset the cost of cleanup and more importantly serve as a strong deterrent to those that trash our city and willingly and selfishly undermine our residents quality of life.

The commission accepts this report but makes the following strong recommendations to Council:

- -The commission recommends that Council directs staff to develop 1-2 options for a robust enforcement mechanism with corresponding cost estimates for each option. Funding for enforcement would come from existing Beautify SJ budgeted dollars. The expected result of strong enforcement would be net financially favorable to the City as new revenue offsets costs and a real deterrent is re-established.
- -The commission also recommends that Council direct the Staff to investigate the feasibility of putting a city ordinance or other strong incentive or mandate in place to require resellers of mattresses in San Jose to offer a free or very low cost recycle program at their stores. Their stores and delivery operations have the reverse logistics capability to handle the reverse supply chain of mattresses and should bear the cost of the waste materials generated every time they sell a new mattress. This cost should not be born by the residents of San Jose. It should be born by those that profit from the sale of mattresses and the waste that those sales create.
