a. Recommendation to City Council for Set Time for Climate Smart Items (Discussion and potential action)

Action: Upon motion by Commissioner Bekele and seconded by Commissioner Remaker. To have committee send letter to transportation and environment committee. Motion was approved (9-0). No public comment.

b. Commission Bylaws(Discussion and potential action)

Action: Commissioner Strawa moved, with a second by Commissioner Bekele, to approve the Bylaws with a specified edit: to clarify that the Chair and Vice-Chair terms will commence immediately following a vote at the November meeting, rather than at a set time. The motion was approved unanimously (9-0). No public comment.

A. Update from Planning, Building, & Code Enforcement on requested policies/programs (Discussion and potential action)

Action: Commissioner Garfunkel and seconded by Commissioner Strawa motion to formally request approval to host a meeting to November or December. The motion was approved unanimously (9-0). No public comment.

B. Transportation semi-annual update (Discussion and potential action)

Action: Upon motion by Commissioner Niemeyer and seconded by Commissioner Wang, to accept staff recommendations of the report and to forward the update to Council (see recommendation on page 4). The motion was approved unanimously (9-0). No public comment.

C. Ad Hoc committee report on SJCE financial status of implications for reserves policies (Discussion and potential action)

Discussion: The commission discussed the purpose and context of SJCE's financial reserves to ensure public understanding. In this context, reserves refer to funds set aside by SJCE to cover periods when revenue may fall below costs, helping to stabilize rates and support ongoing operational costs without immediate recourse to rate increases. The reserves are thus a buffer that enables SJCE to manage financial fluctuations and maintain fiscal stability.

Action: Upon motion by Commissioner Niemeyer and seconded by Commissioner Garfunkel, the commission approved a request for SJCE to conduct a session on reserves

policies at the November meeting, specifically addressing the purpose, calculation, and management of reserves in SJCE's financial framework. The motion was approved unanimously (9-0). No public comment.

D. Ad Hoc committee rules (Discussion only)

Action: None. Bill Charley, Senior Deputy City Attorney, provided guidance on establishing and operating ad hoc committees within commission parameters. No public comment.
