A. Report back from October 2, 2024 Rules and Open Government Committee Meeting. (City Clerk)

<u>Discussion</u>: City Clerk Toni Taber relayed that the Rules and Open Government Committee directed the BFCPP item regarding independent committee disclosures back to the Board for the Board to conduct public outreach. B. Discussion on Report from City Attorney's Office Regarding Implications of Candidates Undergoing Criminal Investigation. (City Attorney)

<u>Discussion</u>: Deputy City Attorney Matthew Tolnay reported to the Board that there are three sources of authority related to this issue: State law, the City Charter, and the San José Municipal Code. The City's two authority areas that could potentially apply would be (1) a provision in the City Charter which discusses the judging of qualifications for the Mayor and Councilmembers and the potential for those offices to be deemed vacant upon certain occurrences and (2) a section of the San José Municipal Code which outlines the process for removal of the Mayor or a Councilmember due to willful official misconduct. There is no specific provision which states that being under investigation for a criminal charge alone would be cause for removal.
