#### RECOMMENDATION

Approve the Auditor's Office Monthly Report of Activities for the month of May 2015.

#### SUMMARY OF RESULTS

Charter Section 8.05(e) requires the City Auditor to submit a monthly report to the City Council of our activities, findings, and recommendations. This report summarizes reports issued, other activities, assignments in process, and the status of the City Auditor's Fiscal Year 2014-15 Work Plan during the month of May 2015.

## **Reports Issued During the Month Of May:**

- 1. Parks, Recreation and Neighborhood Services Department Fee Activity Program We reviewed the calculation, collection, and cost recovery status of the department's General Fund Fee Activity Program. The report made 6 recommendations and was presented at the May 14, 2015 meeting of the Neighborhood Services and Education Committee and accepted at the June 2, 2015 meeting of the City Council.
- 2. Curbside Recycling We assessed the effectiveness of the single-family residential single-stream curbside recycling program, including compliance with contract requirements. The report made 6 recommendation and was presented at the June 1, 2015 meeting of the Transportation and Environment Committee. The audit is scheduled to be presented for acceptance at the June 16, 2015 meeting of the City Council.

### **Activities During the Month of May:**

- City Auditor's Office staff members attended the annual Association of Local Government Auditors (ALGA) conference in San Diego, presenting seminar sessions on mapping, staffing analysis, and use of resident surveys.
- Pedro Hernandez-Bachen will be joining the office for the summer as part of the *Stanford in Government* Fellowship Program. He is a junior at Stanford pursuing an international relations degree. He will be assisting with our audit of the city's volunteer programs.

#### **Assignments in Process:**

**3.** Police Disability Retirement Scenarios – Assess the impact on a sample of police officers of changes in the City's disability retirement system.

**Project Status:** Report writing completed.

**Anticipated Release Date:** June 2015 (Public Safety, Finance and Strategic Support Committee).

**4. Golf Course Fund** – Examine the causes of decline in net operating and maintenance income to the Golf Course Fund.

**Project Status:** Report writing in process.

**Anticipated Release Date:** August 2015 (Neighborhood Services and Education Committee).

**5. Police Recruiting and Hiring** – Analyze the department's recruiting, backgrounding, and hiring processes, and determine to what extent San Jose is subsidizing other jurisdictions with our academy.

**Project Status:** Fieldwork in process.

**Anticipated Release Date:** September 2015 (Public Safety, Finance and Strategic Support Committee).

**6.** Use and Coordination of Volunteers – Various City departments offer volunteer opportunities. By choosing to volunteer, San José residents have the opportunity to strengthen the city, and connect with their families, their neighbors, and their communities through service. The purpose of this review is to evaluate the use and coordination of volunteers to augment City services.

**Project Status:** Preliminary Survey in process.

**7. Street Sweeping** – Curb miles swept has decreased by 34 percent over the last 10 years. Only 45 percent of residents rated street cleaning as good or excellent in the *2013 National Citizen Survey*.

**8. South Bay Water Recycling** – South Bay Water Recycling is expected to generate \$4.6 million in revenue in FY 2014-15 by delivering 5 billion gallons of recycled water from the Treatment Plant to 775 customers (more than 75% of all recycled water used in Santa Clara County).

**Project Status:** Preliminary Survey in process.
