ABATEMENT SPECIAL ASSESSMENT LIENS

Conduct a Public Hearing to consider the adoption of a resolution confirming the report from the Director of Finance concerning unpaid Abatement Costs for the accounts that have remained unpaid as of February 22, 2018, and direct the Director of Finance to place a special assessment against the property secured by a lien to be recorded with the Santa Clara County Recorder's Office.

b. ADMINISTRATIVE REMEDIES LIEN

Conduct a Public Hearing to consider the adoption of a resolution confirming the report from the Director of Finance concerning the delinquent administrative penalties and administrative costs for the account subject to an administrative remedies order that have remained unpaid as of February 22, 2018, and direct the Director of Finance to place a lien against the property to be recorded with the Santa Clara County Recorder's Office.

c. DELINQUENT TREE LIEN

Conduct a Public Hearing to consider the adoption of a resolution confirming the report from the Director of Finance concerning the delinquent tree violations costs and place a special assessment lien against the property accounts that have remained unpaid as of February 22, 2018, and direct the Director of Finance to place a lien against the property to be recorded with the Santa Clara County Recorder's Office.

d. 2399 PLEASANT ACRES DRIVE (652-10-015)- PROPOSED ABATEMENT

The Director of Planning, Building and Code Enforcement requests a hearing to consider the adoption of a proposed abatement order to require the property owner by the end of fourteen (14) calendar days of the date of service of the Board's resolution to remove and properly dispose of all fire damaged items and hazardous solid waste.

Recommendation: Adopt the proposed abatement order requiring the property owner to take abatement action as set forth in the Staff Report dated May 9, 2018.
