Consider a change to the Revolving Door Ordinance that mititgates potential conflicts of interest and simplifies the rules surrounding former designated employees who work for non-profit organizations as lobbyists or on legislative or administrative matters which they worked on as part of their City employment. Potential policy directions include:
  - a) Narrowing the non-profit exemption to 501(c)(3) organizations, regardless of whether the organization had received support from the City; or

b) Striking the non-profit exemption, such that the same rules apply whether former designated employees go to work for non-profit or for-profit organizations.

Taber dated August 31, 2017 with the Audit Report of the City's Open Government (CC 9/12/17, Item 3.6); 2) City Council Synopsis for September 12, 2017, Item 3.6 (page 11); 3) San José Municipal Code section 12.10.010 (Revolving Door Ordinance); and 4) Revoling Door Ordinance Comparison Chart.

<u>Discussion</u>: Sr. Deputy City Attorney Neelam Naidu summarized the referral from the City Council requesting the Board evaluate the non-profit exemption in the City's Revolving Door Ordinance and answered Board questions. Sr. Deputy City Attorney Neelam Naidu notified the Board of AB 551, effective January 1, 2018, deals with postemployment restrictions and could affect the City of San Jose's Revolving Door Ordinance. The Board discussed.

Action: Upon a motion by Board Member Thomas Goodwin, seconded by Board Member Madhavee Vemulapalli and carried, the Board approved the recommendation to strike the non-profit-profit exemption, such that the same rules apply whether former designated employees go to work for non-profit or for-profit organizations. (4-1. Noes: Peacock.) Staff to draft memo for Chair Adrian Gonzales' review and signature.
