<u>Discussion</u>: Chair Adrian Gonzales opened the public hearing. No representative for Complainant Elizabeth Plane nor Respondent Pam Foley for San Jose City Council D9 2018 Committee were present so no testimony given. Public Member Eric Stroker informed the Board that he believes the Respondent is exploiting a grey area of the rules and that the Board should prevent campaigns from exploiting the rules.

Consider a change to the Revolving Door Ordinance that mititgates potential conflicts of interest and simplifies the rules surrounding former designated employees who work for non-profit organizations as lobbyists or on legislative or administrative matters which they worked on as part of their City employment. Potential policy directions include:
 - a) Narrowing the non-profit exemption to 501(c)(3) organizations, regardless of whether the organization had received support from the City; or
 - b) Striking the non-profit exemption, such that the same rules apply whether former designated employees go to work for non-profit or for-profit organizations.
