Call to Order

III. Hearings

A. Hearing on Complaint filed by Bryan Do on February 1, 2016 against Lan Diep for San Jose City Council (2015 Campaign) and Lan Diep alleging violation of the San Jose Municipal Code (Independent Investigator/Evaluator)

<u>Documents Filed</u>: 1) Report from Hanson Bridgett LLP dated February 29, 2016 regarding Bryan Do v. Lan Diep and Lan Diep for City Council (2015 Campaign) Complaint filed February 1, 2016; and 2) Supplemental Memo from Deputy City Attorney Arlene Silva.

<u>Discussion</u>: Vice Chair Rolanda Pierre Dixon opened the public hearing. Evaluator Caroline Lee summarized the complaint and her recomendations to the Commission. Complainant Bryan Do was present. Respondents Lan Diep nor a representative from the Lan Diep for San Jose City Council (2015 campaign) were present. Complainant

Bryan Do provided testimony and responded to Commission questions. Deputy City Attorney Arlene Silva responded to questions to interpretation of "identical allegations."

<u>Action</u>: Commissioner Adrian Gonzales moved that the Commission direct the Evaluator/Investigator to conduct an investigation on the matter based on the introduction of new evidence. Commissioner Chris Peacock seconded the motion, which failed with a 2-2-1 vote. (Noes: Pierre Dixon and Vemulapalli; Absent: Smith)

Action: Vice Chair Rolanda Pierre Dixon moved that the Commission dismiss the complaint and close the matter without further investigation. Commissioner Madhavee Vemulapalli seconded the motion, which carried with a 4-0-1 vote. (Absent: Smith)

Each Commissioner certified that he or she personally heard the testimony at the hearing and reviewed the entire evidence in the record.

Action: Upon a motion by Vice Chair Rolanda Pierre Dixon, and seconded by Commissioner Adrian Gonzales and carried, the Commission moved to direct the City Attorney to draft a Resolution on the Commission's findings, and further, that the Commission authorize the Vice Chair to approve and sign the resolution. (4-0-1; Absent: Smith) Vice Chair Rolanda Pierre Dixon declared the hearing on this matter closed.
