VI. Reports

A. Chair

<u>Discussion</u>: Chair Michael Smith thanked Vice Chair Rolanda Pierre Dixon for chairing the last meeting, which he was unable to attend due to illness, and noted that Commissioner Adrian Gonzales was unable to attend tonight's meeting due to an out-of-town business meeting.

B. City Attorney

1. Legislative update

<u>Discussion</u>: Deputy City Attorney Arlene Silva informed the Commission that the California Government Code changed the threshold at which a person is considered to be a committee from \$1,000 to \$2,000 in total contributions or expenditures. She is preparing an ordinance to revise the definition of "committee" in San Jose Municipal Code Title 12 to coincide with the California Government Code's revised definition, and plans to take the final draft to the City Council for review and approval on June 21, 2016 after reviewing it with the Commission at the June 8, 2016 meeting.

Action: No action was taken by the Commission.

2. Status of outstanding Ethics Commission Resolutions

<u>Discussion</u>: Deputy City Attorney Arlene Silva is working on four resolutions currently and is working with staff on the backlog.

3. Status of Gift Ordinance relating to Mayor's Biennial Review

<u>Discussion</u>: Deputy City Attorney Arlene Silva reported that there will be an update at the June Commission meeting.

4. Election update

<u>Discussion</u>: Deputy City Attorney Arlene Silva discussed the City Attorney's Campaign Guidelines webpage and indicated that the majority of requests for guidance are questions about the campaign contribution limits and electioneering communications. There have been no new entries made since early April.

<u>Documents Filed</u>: Campaign finance statement filing log for the April 28, 2016 deadline.

<u>Discussion</u>: City Clerk Toni Taber reported that all candidates filed their campaign finance statements timely for the April 28, 2016 deadline. There are 245 non-filers for the Form 700 and Family Gift Reports that were due on April 1, 2016; however, the majority are contractors that may no longer have valid contracts with the City. Potential changes to the lobbying ordinance are being reviewed with the City Attorney's Office.

<u>Documents Filed</u>: Informational memo from City Clerk Toni J. Taber to the Honorable Mayor and City Council re Initiative dated April 26, 2016.

<u>Discussion</u>: City Clerk Toni Taber informed the Commission that the Clerk's Office completed a petition signature review on April 26, 2016, and the Opportunity to Work Petition qualified with 34,768 signatures. The Santa Clara County Registrar of Voters is completing a 3% random sample verification which is due by June 8, 2016.

<u>Discussion</u>: City Clerk Toni Taber reviewed the Ethics Commission Expenses FY 15-16 Spreadsheet and will add the remaining balance of the Hanson Bridgett contract in future expense reports for Commission review. Also, in response to a question from Chair Michael Smith, she indicated that the City Clerk's Office will develop a policy regarding use of court reporters to prepare transcripts of Commission hearings and will provide a status report at the June meeting.
