Sergio Jimenez received the majority vote for the Council District 2 seat and Dev Davis received the majority vote for the Council District 6 seat. The Council District 8 seat is still too close to call so it is anticipated that an automatic recount will be conducted by the Registrar of Voters. There are still 40% of the ballots outstanding.

There are three open vacancies (one with a term ending 3/1/19 and two for terms ending 3/1/21). The recruitment closes on January 9, 2017.

<u>Action</u>: Board Member Madhavee Vemulapalli informed staff of an error on the recruitment flyer (term end date of the two vacancies incorrectly showed a term end date of 3/1/23 instead of 3/1/21) and requested the flyer be corrected and reposted.

The ad hoc subcommittee will comprise of Board Members Adrian Gonzales and Chris Peacock. (4-0)

<u>Discussion</u>: Sr. Deputy City Clerk Cecilia McDaniel discussed the plan to create a brochure as requested by former Vice Chair Rolanda Pierre Dixon. The Board discussed possible ways for diverse community outreach regarding campaign and ethics regulations and procedures.

<u>Action</u>: The Board directed staff to work with Board Member Chris Peacock to develop a draft brochure (i.e., How to participate in local government and make your voice heard) for review by the Board. The brochure should include information about how to properly support and/or oppose candidates.
