The FPPC is also undergoing a comprehensive review and revision of the Political Reform Act to ensure decades of amendments are given clarity and continuity.

<u>Public Comment</u>: Illysha Peete with Breathe California; Todd Hansen with The Health Trust; Patrick Soricone with Somos Mayfair; Bob Browstein with Working Partnerships USA; Colleen Haley with Destination: Home; and Wendy Ho with Silicon Valley Council of Nonprofits all spoke out against requiring non-profits to register as lobbyists in the City of San Jose as proposed in Councilmember Johnny Khamis' Memorandum.

<u>Action</u>: Upon a motion by Chair Michael Smith, seconded by Board Member Adrian Gonzales and carried, the Board approved the ordinance as presented and requested that references to the Ethics Commission be changed to reflect the new name of the Board. (3-0-2. Absent: Pierre Dixon and Peacock.)

<u>Discussion</u>: Deputy City Attorney Arlene Silva reviewed the recently adopted City Council Resolutions and Ordinances affecting the Board and answered questions. City Council Resolution 77879 was adopted as approved by the Board. Some aspects of City Council Resolution 77891 apply to the Board, but not all since the Board is quasi judicial. City Clerk Toni Taber informed the Board Members that they will be receiving City of San Jose email addresses that they should use when conducting Board business. Action: The Board Members agreed that the biennial review of Title 12 would be the appropriate time to amend City Council Resolution 77879 with the new Board name. The Board directed staff to draft Board Bylaws and bring to the next meeting for review.
