- B. City Attorney Deputy City Attorney Arlene Silva reported that with the new year, there are some new laws in effect, and she will be reporting on these at a future meeting. She indicated that Ethics and Brown Act training was provided to the five incoming new Councilmembers and their staff.

<u>Discussion</u>: Deputy City Attorney Arlene Silva advised removing Items VI.B(1), VI.B(2) and VI.C from future agendas, instead tying these items to the elements of the Work Plan addressing recommendations for revisions to Title 12 and associated documents. Chair Michael Smith noted that, beginning at the April 2015 meeting, the Commission will take a look at issues that have presented themselves through the past year for discussion and prioritization.

Regarding the Status on Independent Evaluator/Investigator RFQ, City Clerk Toni Taber advised that the RFQ has been forwarded to Purchasing for processing and that she will ask that it be expedited. The interviews should be held no later than the June meeting, after which the Commission's recommendation for a contract award must be approved by the City Council, most likely on the Consent Calendar.

Action: The Commissioners agreed by consensus to remove Items VI.B(1) and VI.B(2) and VI.C from future agendas, instead adding these issues to the existing list of items for further discussion at the Ethics Commission meeting in April.

D. Discussion and possible action on establishing an Ethics Commission ad hoc Subcommittee to explore opportunities for outreach to ethnic and specialized media regarding campaign and ethics regulations and policies per the Commission's FY2015 Work Plan. (Chair)

<u>Discussion</u>: Deputy City Attorney Arlene Silva advised that following the recent Dinh v. Cortese hearing, outreach misinformation was provided within the Vietnamese community. Strategies were discussed for educating the community in preventing future campaign violations. Pamphlets on 'how to participate in local elections', in other languages and without editorializing, were suggested. Creation of a draft to be reviewed by an Ethics Commission ad hoc subcommittee was recommended. City Clerk Toni Taber agreed to check with Orange County, San Diego and San Francisco to determine their education process and review their literature.

Action: Upon motion by Chair Mike Smith, seconded by Vice Chair Rolanda Pierre Dixon and carried unanimously, Vice Chair Rolanda Pierre Dixon and Commissioner Chris Peacock were appointed to serve on an ad hoc subcommittee to explore opportunities for outreach to ethnic communities to educate them regarding campaign and ethics regulations and policies. (3-0.)

E. Schedule Update on Continuing Investigation of Complaint filed by Bui Dinh on October 14, 2014 alleging violations of San José Municipal Code by Dave Cortese and Dave Cortese for Mayor 2014. (Chair)

Chair Mike Smith indicated receipt of a letter from Investigator/Evaluator Steve Miller of Hanson Bridgett outlining progress made on the investigation in the complaint of Bui Dinh v. Dave Cortese filed on October 14, 2014 and indicating his intent to submit a report in time for the Commission's February, 2015 meeting.
